

# New England Local Masters Swimming Committee 2022 Annual Membership Meeting Minutes October 22, 2022

- 2) Adoption of the minutes from the February 2022 Winter meeting
  - a) Motioned, seconded, and approved (MSA) by voice vote.
- 3) Treasurer's Report for the past fiscal year David Grilli
  - a) David presented the 2022 NELMSC budget vs. actual expenses incurred for October 1, 2021, through September 30, 2022.
  - b) The surplus as of September 30, 2022, is \$12K. That is two years in a row with a surplus, mostly due to less spending during the pandemic.

- c) Total assets, which are all in cash, are \$44K as of September 30, 2022. An additional \$4K is in the NELMSC Hall of Fame bank account, which is funded by member donations.
- d) The Federal Tax Return was filed for calendar-year 2021.
- e) The 2021 NELMSC financial report was prepared and submitted to USMS.
- f) Guy Davis reviewed the financial statements and bank accounts and found no issues.
- 4) Officer / Committee Reports (also see the attached written reports)
  - a) **Communications:** (Kysa Crusco) Goals are to continue the e-newsletter in 2022 and continue posting photos and videos from swim meets and other events. Kysa manages both the NELMSC Facebook and Instagram pages.
  - b) Para-Athlete: (Laura Dennison) A para-athlete survey was done and published in 2021. USMS has appointed a Para Coaches Chair. Upcoming events: Para coaches clinic (it's free) on November 6, consisting of watching a para-swim workout in-person followed by a training session. USMS has scheduled a virtual para-coaches clinic on November 6. Laura has volunteered for the USMS Diversity & Inclusion committee.
  - c) **Coaches:** (Ben Hammond newly appointed) I am a coach at JCC in Newton. Coach development clinics and swimmer clinics are on my radar. Three clinics for coaches are planned for 2023.
  - d) **Sanctions:** (Jason Weis)
    - i. We are back to seeing more meets than before Covid. We are always looking for new meet venues. I am swimming at BU and looking into meet possibilities there.
    - ii. There is a new process for post-Covid-safety at swim meets.
    - iii. At recognized meets, there needs to be a "Designated Observer" present to verify in writing that the conduct of the meet conforms to USMS swimming rules and administrative regulations.. The full requirement is outlined in the Sanctions section of our NELMSC website.
  - e) Hall of Fame: (Tracy Grilli) The 2022 NELMSC Awards & Hall of Fame Induction Celebration was held as a luncheon on July 17 after the Jenny Thompson swim meet. There were 60 attendees. Tracy reported that many LMSCs do not have halls of fame, and she has created and distributed a HOF "How To" guide. The word is spreading e.g., Illinois is having an HoF induction this year for the first time.
  - f) Officials: (Sue Jensen) We have 24 officials active in our region. Ken Galica will serve as referee and is assembling officials for the NELMSC SCM championship meet at WPI in December. Compensation: WPI pays each official \$200 per full-day session and \$100 per evening session. It is proposed that the NELMSC contribute an additional \$50 per full-day and \$25 per half-day. Twenty-five people attended an officials training session earlier this year. We have encouraged our officials to take advantage of USMS's resources for officials. We would like to do referee training next year. College Club Swimming meets do not have to be certified and having only one person as the starter makes it a valid club swim meet; additional officials are welcome but not required.
  - g) Awards: (Tara Mack) Had a great awards ceremony in July 2022. At the USMS annual in September 2022, Al Prescott and Laura Dennison received national awards. Doug suggested nominating more NELMSC members for the USMS Dot Donnelly Award in 2023.

### h) Vice Chair: (Guy Davis)

- i. Elections: The next NELMSC officer elections will be in 2023.
- ii. Member fees: There will be an increase in USMS fees for 2023: \$65 individual member before January 1st, then \$70.
- iii. Open Water: Guy is preparing an Open Water webinar for 2023 to introduce open water swimming to a wider audience and allay any OW swimming fears that may exist. Guy is also developing an online list of open-water swimming groups and venues around New England.
- iv. USMS finances: USMS is financially stable. It received \$500K in pandemic relief funds in 2021 and has a \$4 million reserve fund. Total USMS membership was over 50K in 2021 and is over 55K in 2022, which exceeded expectations.

### i) Membership: (Douglas Sayles)

- i. NELMSC membership stats: 1,500 in 2021, and 1,862 in 2022. (The all-time high was 2,520 in 2017.) Many small and less-organized clubs and workout groups disappeared during the pandemic and are not coming back, but most of the more well-organized teams are back to or above pre-pandemic levels. More younger swimmers are joining than usual. New England has always had pool-availability issues when compared to some other parts of the country. The NELMSC has covered the 2023 renewal fee for 9 clubs and 28 workout groups to date.
- ii. Team building: Teams should consider promoting a team event and social gathering every month or two to support USMS registration/renewal, team identify, and member satisfaction, especially between November and March.
- j) **Open Water:** (Jen Downing) Four sanctioned open-water swim events are planned for 2023. Guy plans to organize a virtual open-water clinic.
- k) Championship Meet Subcommittee: (Sue Jensen) Registration is open for the 2.5-day NELMSC Short Course Meters Championship meet at WPI, December 9-11, 2022. We are searching for a venue for the NELMSC Short Course Yards Championship in March/April: we reached out to 10 pools but eight declined to host the SCY meet. Brown and WPI are interested in hosting the SCY championship, and Colby is interested in hosting a summer LCM championship, including use of dorm rooms.
- At-Large (Fitness): Doug stated that At-Large Fitness Chair Bill Meier would like to teach an ALTS instructor certification course in New England in 2023. The date and budget are TBD.

### 5) Unfinished Business:

a) NELMSC Swimming Records Database: Alana established a task force. Bill Ryan and Mark Bernasconi (who has a data management background) volunteered. Crystie and Doug are available to consult. Doug reported that the Colonies Zone is also investigating more efficient zone record-keeping options but has encountered several obstacles, including technological challenges related to the lack of national office support and dependency on a single individual to program and manage any new record-keeping system or process.

#### 6) New Business:

- a) NELMSC will again send members in-person and virtually to the 2023 USMS Annual Meeting and the 2023 USMS Volunteer Relay.
- b) Coach Training Budget: The Coaches Chair report proposed scheduling USMS Level 1, 2, & 3 coach certification courses with a NELMSC \$50 subsidy for the first 30 registrants in each course. Doug noted that Level 1 is now an online course and proposed an amendment to

offer a USMS Boston Education Weekend with a Level 3 coach certification course (which the NELMSC has not offered in several years), a "How-to" Coaches Clinic Course, a Swimmer Stroke Development clinic, and an ALTS instructor certification course, with \$150 subsidies for the Level 3 course registrants and ALTS course registrants.

- i. MSA as amended to work with USMS on a 2023 Boston Education Weekend with the courses described above and \$100 subsidies for Level 3 course registrants and \$50 for ALTS course registrants. [February 2022 Update: The Boston Education Weekend courses and subsidies have been expanded (click for details). If needed, the extra course subsidies will be funded by the Coach-Swimmer Clinics budget line item.]
- c) Diversity & Inclusion: Laura proposed to write up the venue accessibility features (and gaps) for each pool where a NELMSC swim meet is planned and include this information on the meet registration page.

### 7) New Proposals:

a) Doug proposed that the NELMSC investigate the feasibility of hosting a large, competitive New England Open Water Swimming Festival that has a national draw as a marquee destination event. The USMS CEO suggested that the NELMSC host this type of event. Task Force: Doug, Alana, Guy, Bill Meier, Jen, others TBD as needed.

### 8) Resolution and Orders:

- a) Per David's request, the board agreed to change the NELMSC budget tracking & reporting year to mirror the USMS registration year (Nov 1 Oct 31). Previous NELMSC annual budgets had been prepared and approved at the NELMSC annual membership meeting for the next calendar year (Jan 1 Dec 31).
- b) The board reviewed, amended, and unanimously approved the 2023 NELMSC budget (attached) for Nov 1, 2022, through October 31, 2023. Most of the projected revenue is based on 1,500 members @ \$13 each for total revenue of \$19K. There is a projected 2023 \$8K budget deficit due to increased spending resulting from a concerted effort to spend down the NELMSC's current \$50K reserve.
- 9) The meeting was adjourned at 2:03 p.m.

(\*Initiative) Thankful for the Ember Wood Fire Grill for hosting this year. Our preference is to lock in a date ahead of the summer season and then announce a location whether or not it aligns with the JT Meet or any particular summer meet will remain unknown.
- 2 I have extended the nomination window for the Frank Wuest OWS award for 2022 until Oct. 17, 2022. The past few years have certainly thrown off the awards and nomination process and OWS has seen a great uptick

in participation and enthusiasm. I had thought that recognizing this or these athletes at our annual meeting could be beneficial for the timing such that it would be at the conclusion of the season. - 3 I continue to brainstorm ideas about some 'smaller' more frequent recognition opportunities. I have researched some "Swimming Shout Outs" as a way to allow people to nominate and acknowledge the 'little things' that mean so much. Ex. A swimmer nominates a fellow swimmer for always being such a positive role model at practices and in life. I send this swimmer a "You're Awesome" sticker (example) with NELMSC logo on it (customized) and we post quarterly the people who are recognized and of course on IG and FB too. Also open to ideas and suggestions.

#### **Recent/Current Initiatives**

- 1. Hosted our 2<sup>nd</sup> Annual NELMSC Awards and Hall of Fame Induction Celebration at Ember Wood Fired Grill on Sunday July 17, 2022. - 2. Celebration Having the celebration immediately following the Jenny Thompson meet has been a real positive. The negative is we do not know the date of the meet until late in the year and find it difficult to find an appropriate venue to host our event on such short notice. The committee will be considering options including setting a specific day each year (example 2<sup>nd</sup> Saturday in July) for the celebration in addition to finding a location more centrally located.

#### **Current Initiatives**

- 1. <u>WPI SCM Champs meet officials</u> Ken Galica will be the meet referee. He is currently assembling a team of officials 4 for Friday evening, and 8 each weekend day.
- 2. Compensation for officials our meet officials typically earn \$200 / day (\$100 / half day/evening sessions) to officiate at our championship masters swim meets. I'd like to propose that our LMSC supplement this compensation \$50 per day per official (\$25 for evening sessions). I feel this is fair consideration for their time and travel, and hopefully a gesture that they appreciate and will make them want to work future USMS events. We staff with 8 officials on weekends and 4 officials on Friday evening.
- 3. <u>List of Active Officials</u> -- I will continue to maintain my list of officials who are eager and willing to officiate at masters meets. There are currently 25 officials on my list.
- 4. Officiating opportunities -- I will continue to let my group of officials know of officiating opportunities -- both locally in New England, and at the national U.S. Masters meets.
- 5. <u>2023 Rule Books</u> I will order rule books for my team of officials, based on their requests (mini, or full-sized). For those who do not want a rule book, I will let my group know that the full rule book is always available on the USMS website.
- 6. <u>U.S. Masters Swimming's Officials Certification Program</u> -- I will continue to spread the word to my current group of officials (and others wishing to become a meet official) of this certification and training program. Officials can get certified and recertified -- for stroke and turn, starter and referee positions -- directly through U.S. Masters swimming's website and related videos.

- 1. Officials Certification Training Clinic -- I will consider hosting another training clinic -- as I did in January 2020 with Ken Galica -- if I feel we are in need of more certified officials in New England for our local masters meets.
- 2. <u>Meet evaluation reports</u> -- I may consider asking Meet Referees to write a Meet Evaluation Report after each major championship meet. The report would then be reviewed by the NELMSC Board. The goal would to enable future event improvements.
- 3. <u>USA-Swimming Local Swim Committee (LSC) counterparts</u> -- I'd like to reach out and be more in touch with my USA Swimming officials counterparts. Could definitely learn from their initiatives. Consider coordinating a clinic for both USA Swimming and U.S. Masters Swimming officials to be certified.

For 2023 budget, I'd like to request 4x \$500 OW sanction subsidies for a total of \$2,000. I'd also like to keep \$800 for an OW clinic please. I'd like to explore an order of NELMSC-branded swim buoys for the clinic or ALTS sessions – maybe \$250 to start?

#### **Current Initiatives**

- 1. NELMSC was able to approve 4 OW sanctions in Summer 2022: Charles River Swim (6/18), MBCC Against the Tide in Hopkinton (6/18), MBCC Against the Tide in Brewster (8/13) and Glen Lake (8/14). These are all repeat events from prior years and while the Charles River and Glen Lake swims were well attended and their OEVT process went smoothly, we struggled yet again to attract swimmers for the MBCC events. Partially it's that their dates always conflict with other swims and they're a charity fundraiser. I know the MBCC organizers want us to promote more but beyond blasting on social media and posting on USMS/NELMSC calendars I'm not sure what else we can do. I'm not sure we're going to get more OW sanction requests, so I reduced my budget request from 5 events to 4 for 2023.
- 2. Updated OW section of NELMSC website, including links to USMS resources and latest COVID protocols. Will also help encourage nominations for Frank Wuest OW Award.

- 1. With Phil White dropping out of hosting duties for USMS OW Nationals, I'm not sure there are any other obvious venues willing to host but it would be great publicity for NELMSC to have another large-scale event in our region.
- 2. Bob Ouellette and I had talked about possible OW clinic during the pandemic, but we never quite got something off the ground given covid restrictions. Recently, Guy Davis volunteered to spearhead an 'introduction to OW' zoom series next spring and I will assist as much as my schedule allows.
- 3. Would like to explore an order of NELMSC-branded swim buoys after the DCR mandate that all OW swimmers use one. There might be an opportunity to include these buoys with the zoom training (or clinic?), assuming that most participants won't already have one. We could also tie them in to ALTS month if that would be appropriate.
